### **WHY CONSTRUCTION 2020?**

- The current shape of the construction sector
- In 2012, volume of production in sector fallen by <u>over 75%</u> compared with 2006 and is still less than half the volume it was "pre-boom" in 2000
- Contributed 6.4% of total GNP in 2102
- 80% drop in employment amongst "brickies" and labourers
- Supply not meeting Demand
- NOT FIT FOR PURPOSE

- 75 actions
- D/Environment has 30+ actions
- Local Authorities explicitly has 15 C2020 actions
- Overseen and managed by an inter-departmental group of Secretaries
   General

## **Construction 2020 - Key Commitments**

- Informed Housing Policy through A National Framework for Housing Supply and Annual statement of projected supply and demand
- Housing Supply Coordination Task Force for Dublin
- Sustainable bank and non-bank development financing
- Transparency & sustainability of mortgage lending and new models
- Supporting ex-construction workers on the live register
- Professionalising the private rental sector

## Construction 2020 - Key Commitments Contd.

- Flexibility around densities in planning applications
- More streamlined planning and appeal processes for the amendment of existing planning permissions
- "Use it or lose it"
- Proper building standards and regulation
- Strengthening capacity in the sector
- Register of builders contractors and construction trades

## **Social Housing Strategy**

- 89,872 households with social housing need (2013)
- Changing demographic of people on the list
- Clear, measurable actions based on innovative solutions & new funding mechanisms
- Supply of SH being ramped up as announced in the Budget 2015 on Tuesday

### **BUDGET 2015**

- Provision for Housing increased by over €210 million in 2015 with Capital funding increased significantly by €180 million. Total - €800m
- Over 7,500 new homes to be provided under a range of social housing initiatives in 2015.
- A capital investment package of €350m over the next three years will provide
   8,000 new-build, acquired or refurbished social homes.
- An additional €150m will be provided in the same period through leasing and other revenue based funding arrangements.
- €300 million PPP Programme for 1,500 new Social Housing units in Dublin area

### **PART V**

Part V is directly related to private housing construction - Strength? Weakness? Both? Accordingly, since the downturn, Part V has delivered little in terms of social housing Part V out of step with new reality of the construction sector

#### PART V - OUTCOME OF REVIEW

- On-site delivery of 10% SH Units (developments of 9 Units +) mixed tenure model
- Secondary option, 10% SH units at another location
- Monetary payments in lieu of SH units discontinued
- 10% "affordables" requirement discontinued kick-start housing construction
- Retrospective application Committee Stage
- PAs required to consult with AHB in the preparation of their housing strategies
- PAs to take into account relevant Government Strategies housing strategies
- Some technical amendments
