The arts, as defined in the Arts Act 2003.

"Any creative or interpretive expression (whether traditional or contemporary) in whatever form, and including, in particular, visual arts, theatre, literature, music, dance, opera, film, circus and architecture and includes any medium when used for those purposes."

Arts Council overview

 Founded in 1951/2. The Arts Council is the national agency for developing, promoting and funding the arts in Ireland.

Core Function

 Arts Act 2003 – "to stimulate public interest in the arts; to promote knowledge, appreciation and practice of the arts; to assist in improving standards in the arts; and, to advise the Minister and other public bodies on the arts."

Role of the elected member Legislation -Arts Act 2003

Section 6. -(1) A local authority shall, for the purposes of section 67 of the Act of 2001, prepare and implement plans for the development of the arts within its functional area and shall, in so doing, take account of policies of the Government in relation to the arts.

-(2) A local authority may provide such financial or other assistance as it considers appropriate to such persons or in respect of such activities, projects or undertakings, for the purposes of—

(a) stimulating public interest in the arts,

(b) promoting knowledge, appreciation and practice of the arts, or

(c) improving standards in the arts, within its functional area.
