Funding Provision and Delivery Mix



- Significant capital envelopes for social housing delivery
- Local Authority led delivery
- AHBs key delivery partners underpinned by funding
- Role of PPPs
- Reduced reliance on acquisitions
- Phasing out Long-term Leasing
- Increased provision for Mortgage to Rent

Delivery Targets for Local Authorities



- Minister issued targets to local authorities September 2021
- Targets for period 2022-2026 for build and long-term leasing
- Individual build and long-term leasing targets – 47,600 build, 3,500 long-term leasing

Delivery at local authority level



- Housing for All requires each local authority to prepare and submit a Housing Delivery Action Plan to the Minister by December 2021
- Details of where, when and how of delivery
- Plan should include –
- An outline of locations where housing will be delivered and the planned numbers of homes to be delivered in each area and by year
- Details of existing land holdings and land acquisition required to deliver the
- o targets in the Plan;
- An outline of planned delivery streams used to meet the targets, including the role of the Approved Housing Bodies /LDA or other partners

Housing Delivery Action Plans



- Housing Delivery Action Plans should address housing types and
 - sizes, in accordance with local need
- the adequate proportion of 1-, 2-,3- and 4- bedroom homes aligned with those needs;
- the provision of housing for people with a disability and the provision of Age Friendly Housing
- Targets for the use of vacant properties as social housing through Buy and Renew, Construction and Repair and Leasing schemes.

Supporting Local Authority Delivery



- Increased staffing for Local Authority Housing Delivery Teams
- Funding commitment to provide new long-term housing posts
- Accelerated approval process to ensure resources in place
- Additional resources for HDCO
- Streamlined approval processes
- Support to acquire land for social housing

Support Social Inclusion



- Expand Housing Options for Older Persons
- Increase Housing Supports for People with a Disability
- Support Traveller Accommodation
- Support International Protection and Refugee Accommodation

Current issues and challenges



- Record level of funding in place for Budget 2022
- Capital investment at record levels
- Significant work completed to prepare Housing Delivery Action Plans – to be published by June 2022
- Strong Pipelines being developed HDAPs have promoted more strategic long-term vision
- Land acquisition and engagement with Irish Water
- Challenges presented by construction inflation engagement on procurement procedures
