


Origin of Policy

TCF Approach – key features




- Creating the vision: Collaborative plan-led approach based on diagnosis
 of local challenges and tailored response to match
- Community Engagement and Buy-in: Essentially to draw widest support for actions
- Local Championing: Need for strong local governance and collaboration
- Business Case: proposed actions to be examined comprehensively to identify risks and opportunities
- Deliverability: Focus on implementation.



TCF Key elements

- Launched 4th February
- 33 Actions and owners
- Local supports and national structures
- Integrate existing work and capacity build
- Greater focus for funding on TCF policy




TCF Some Key Policy Elements

 - Research and analysis
- National Oversight & Advisory Group
- TCF Plan project/outcome focused and prepared by Town Teams of local stakeholders

- ✓ Funded e100,000 each for preparation of the plan




Funding from a variety of sources to deliver TCF plan implementation and support place-based development at a town scale



- Funding and Actions to support



TCF & the Vacancy Issue...

- TCF provides overall strategy and actions for Town Regeneration including in relation to vacancy
- Full-time Vacant Homes Officers (VHOs) now in each LA
- Working with TROs on the vacancy issue specifically
- Providing assessment of vacancy problem in towns and inputting to TCF Plan preparation
- Coordinating vacancy actions with overall TCF strategy for a town
- Integrating vacancy funding proposals with wider TCF funding applications and projects




Croí Cónaithe (Towns) Fund

- ✓ Stream 1 Refurbishment
 - Buildings built pre-1993
 - Vacant >2 years
 - Grant e30,000-50,000
- ✓ Stream 2 Sites for Self Builders
 - Discounted site offered by LA
 - Applicant seeks planning permission for dwelling
 - Pilot Scheme

Targeted at Owner Occupiers – Clawback <10 years

Managed by VHO in Local Authority
