## 1. Who We Are

The Association of Irish Local Government (AILG) was formally established in July 2014. The association has two parent associations - the Association of County & City Councils and the Association of Municipal Authorities of Ireland. Following the local government reforms of 2014 both organisations merged voluntarily to form the Association of Irish Local Government.

The AILG is a **networking, policy development and training resource** for the elected members of Ireland's thirty-one County and City Councils. Through regular interaction with other stakeholders in the local government environment AILG aims to ensure that the contribution of Ireland's democratically elected councillors is appreciated in government departments and throughout the full range of public agencies.

The growth of AILG over the past eight years has been propelled collectively by the elected members and all the past presidents and past members of the Executive Committee.



# Governance, Responsibilities and Structures

The AILG is governed under both the 2001 and 2014 Local Government Acts, following a merger of the two previous national representative bodies after the 2014 local government reforms.

The Association is structured on each of the 31 local authorities nominating three delegates to AILG (93 delegates in total) for the full 5 year-term of any local election period. We have 3 full-time staff members.

# Governance, Responsibilities and Structures

#### **AILG Organisational Development**

In 2021-22, AILG continued to carry out a detailed review of the Association to plan strategically for the long-term future, work and role of the organisation. A Working Group was put in place by the President early in the year to oversee two strands of work which would see AILG carry out a full review of its current constitution and continue its organisational development.

The Working group comprises of the AILG Officer Board, Cllr. David Maxwell, Cllr. John Paul Feeley, Cllr. Conor McGuinness and is chaired by Cllr. Anne Colgan. Over the course of six months, the Working group scrutinised the current constitution, line by line, and began drafting a new document. The association's goals and responsibilities were redefined and enhanced, and improvements were introduced to address important areas including gender balance, governance, and the Irish language.

The Working Group engaged with each party group and consulted with party group leaders throughout the review process to ensure consensus on proposed changes. Following months of work and preparation, a new proposed draft of the AILG constitution was circulated to party group leaders and Plenary delegates for discussion and examination.

The Plenary body approved the new constitution at their meeting on 14 July 2022, which will come into effect in June 2024.

In addition to reviewing the constitution, the Working group also reviewed key business processes and set about the task of progressing key strategies relating to Training and Development, Policy, and Communications. A staffing review was carried out in conjunction with the Institute of Public Administration (IPA) to identify staffing requirements needed to achieve the goals and objectives of AILG over the coming years. The results of this review are expected in early 2023.

## **AILG Advocacy Programme**

## 1.1 Non-financial supports to ease Workload of Members

As the world slowly began to return to normal proceedings following two years of living through the COVID-19 pandemic, AILG continued its active lobbying campaign for better terms and conditions on behalf of our members. Following the successful outcome of the review of our member's remuneration in 2021, the Association welcomed the opportunity to focus on other issues of local government concern including AILG's continued engagement and participation to deliver the non-pay recommendations identified in the Moorhead report.

AILG resumed its participation in the three subworking groups formed by the Department of Housing, Local Government and Heritage as part of the Action Plan to deliver the non-pay recommendations set out in the Moorhead Report. The three working groups focus on the following key themes; Training and Education, Governance and Communications and will remain in place until 2024.

2023 will see a number of key projects emerging from these subgroups to support the development and education of our members, and promote awareness of the role of local government in general, including a separate communications campaign highlighting the valuable role and contribution of the councillor.

## New Vouched Allowances and Gratuities/Pension provisions for Members

Significant changes were also introduced in the form of the Local Representational Allowance (LRA) for elected members which came into effect on 1st January 2022. In late December, AILG published an easy-to-read explanatory note, including best practice guidance and sample templates for all

elected members in relation to the operation of the new allowances regime. The Association also proactively engaged with Department Officials and sought clarifications on some areas following extensive consultation with its membership. The AILG also made numerous representations to Ministers in the Dept of Housing, Local Government and Heritage and to the Revenue Commissioner that the SPC Chair allowance become taxable no earlier than the 2024 Local Elections.

Following the long-awaited increase to our member's pay in line with the recommendation from the Moorhead Report, it was identified by AILG that the salary uplift did not transfer across to an enhanced gratuity calculation. At its meeting with Minister Burke on 22 February 2022, the Association reiterated that it was the expectation of our members that the calculation of the gratuity payment would be based on remuneration at time of retirement rather than the previous representational payment figure.

Over a number of months Cllr. Nicholas Crossan and members of the 2021-22 Executive implemented a number of key actions to progress this issue. The Association sought professional legal advice pertaining to the matter and obtained a legal opinion from a Barrister specialising in Employment Law. The President and Officers have maintained a consistent dialogue with all Ministers in the Dept of Housing, Local Government and Heritage in relation to the issue and AILG will be continuing its engagement with the Minister on the gratuity question as a priority and hope to bring this to a satisfactory conclusion in early 2023.

The establishment of an interdepartmental committee to consider retirement provision for councillors post 2024 is due to commence shortly and AILG will carry out extensive consultation with our members to feed into this working group.

## 1.2 Greater Participation, Retention& Diversity in Local Government

## **AILG Provide Secretariat for WoMeN'S Regional Caucus**

Following a successful joint funding application, AILG & SHE were allocated funding of €5,000 by Minister Burke, T.D., in June 2021 to establish a Midlands, Northern & Western (MNW) Regional Women's Caucus in counties Donegal, Leitrim, Sligo, Mayo, Galway County, Galway City, Roscommon, Cavan, Monaghan, Longford, Westmeath, Laois and Offaly.

The councillors from the caucus region first met on 1st September 2021 and agreed to form a caucus. Their inaugural meeting was held on 29th September 2021 and a constitution, as well as roles and responsibilities, were agreed. Once procedural and operational matters were agreed upon, the caucus moved to design its Programme of Work.

The working group then got together online over a number of meetings to discuss how best to progress the caucus and to discuss potential items for the programme of work. The Working Group brought those ideas and proposals to the wider membership at an online plenary meeting. As part of trialling a new flexible way of working better suited the needs of women councillors, recap online briefings and online polls were held to include those who couldn't attend meetings.

The Caucus Programme of work was then formally approved at the Caucus's first in-person meeting in June of this year. On Tuesday 22nd November, members of the WoMeN's Regional Caucus, led by Chair Cllr. Carmel Brady, met with members of the Women's Parliamentary Caucus in Leinster House to discuss their work programme & areas of

common interest. Following a general discussion on the projects and working conditions for female politicians at all levels of government, both caucuses identified a number of areas where they could collaborate and offer support.

The accomplishments of the caucus to date are attributable to the commitment of the councillors, an experienced secretariat provided from the resources of AILG and SHE, and a professional facilitator to manage efficient and well-thought-through decision-making. The facilitator's role also includes reporting on the learning from the establishment and progress of the country's first regional caucus and will be a valuable addition to the Department's knowledge of this important new political institution within Irish local government.

## Launch of Family Friendly Toolkit to support family friendly policies in Local Government

In September 2022 the National Women's Council of Ireland launched a family friendly toolkit for local authorities on how to encourage women into local government and to support councillors with family and caring commitments. Former AILG President Cllr. Mary Hoade was part of the Steering group who met online to provide expertise and advice to NWCI on the research methodology which informed the development of the toolkit to ensure its relevance and practicality for elected members.

Recommendations from the toolkit included providing a comprehensive induction to councillors when they are first elected or co-opted and providing a dedicated point of contact or Account Manager for councillors as part of its Customer Service Team.

## **AILG Advocacy Programme**

#### **Maternity Leave Provisions for Members**

In July 2022 AILG welcomed the announcement by Minister Peter Burke TD of Cabinet approval to draft a general scheme to grant an entitlement of maternity leave to councillors. The scheme offers the choice to appoint an individual as a temporary substitute in the place a councillor who takes a period of maternity-related absence or is absent due to illness. Elected Members will also have the option to avail of administrative support to assist them in their maternity time to give them extra time to care for their infant if they so wish and choose to keep working in the council chamber with their representative role.

The lack of proper maternity leave has long been cited by AILG as a barrier to women entering politics and the announcement is a significant

advancement and support for women councillors. In September 2022 the AILG made a submission to the Joint Committee on Housing, Local Government and Heritage on pre-legislative scrutiny of the General Scheme of the Local Government (Maternity Protection and Other Measures for Local Authority Elected Members) Bill 2022.

The Association made clear in our submission that AILG would welcome the opportunity to contribute to the work of the committee and are available to appear before the Joint Committee in relation to this important bill for our members.

# 2 AILG Policy Programme

"The objective of AILG policy development is to see the Association of Irish Local Government become an influential participant in the formulation of policy relating to local government in Ireland."

The AILG monitors the output of the Dept. of Housing, Local Government and Heritage and other government departments and State agencies to identify proposals in terms of policy and draft legislation which would enhance or circumscribe the powers of councillors. The association's policy agenda is informed by the Programme for Government agreed in summer 2020 and the Government's announcement of legislative priorities at the beginning of each Dáil session.

In addition, the Association listens to the input and feedback from councillors received through its committee structures and from its engagement with councillors on a wider basis through its online and in-person training. The AILG subjects new draft legislation published by Government to scrutiny so as to assess any implications for the powers of elected members and local government.



#### 2. AILG Policy & Advocacy Programme

#### **Higher Education Bill**

The AILG engaged with the progress of the Higher Education Bill from its inception including the commissioning of an independent expert report, conducted by Dr. Bríd Quinn, B.Ed (NUI), MA & PhD (Limerick), which was submitted to the Oireachtas Committee on Education, Further and Higher Education, Research, Innovation and Science as part of their pre-legislative scrutiny of the bill in April 2021. This was followed up with an appearance before the committee in July 2021.

The Association renewed its lobbying efforts on this issue in 2022 with TDs and Senators and fought to ensure that councillors remained on governing authorities. The association's case was principally that having councillors on the Governing Bodies ensured that the public interest was represented in the State's higher educational and training colleges. Regretfully, no significant support was received to guarantee the inclusion of city or county councillors on Higher Education Authorities. Currently there are 19 councillors on Boards in Educational Institutions across the country but Councils will now no longer be in a position to make nominations to fill these appointments to HEA's.

It is a further erosion of powers and functions of councillors and local government and this comes as a great disappointment to AILG particularly given the long service councillors have given to the sector and the detailed paper and campaign led by successive AILG Presidents and Executives.

#### **DHLGH Planning Forum Group and AILG Input**

Following a commitment under the Government's national plan for housing, The Minister of State for Planning and Local Government, Peter Burke TD, established the Planning Advisory Forum in late November 2021. The Forum's primary aim is to advise the Minister on the evolving policy and legal agenda relating to planning matters and met on a regular basis over the course of the year to exchange views on evolving policy, draft planning guidance and to discuss the planning legislative agenda.

Following the appointment of Vice-President at the time, Cllr Nick Killian, to the advisory forum, and to facilitate his input to Planning Advisory Forum, the Association established an informal working group and consultation process with members. This was done by way of round table discussion at the Plenary Meeting of the Association in late December 2021.

Of particular concern to the Association was a recommendation that the CDP takes place every 10 years instead of every five. The AILG engaged with the Minister and Chair of the Forum Minister Peter Burke to highlight the association's concern in this regard. At the time of print, the Attorney General's Office and Department are working intensely to finalise the Draft Planning and Development Bill, with the intention that this will go to Government before Christmas. A Planning Advisory Forum meeting is planned early in the new year which will run through the key policy highlights in the new Bill.

## 2.2 DHLGH Review of Municipal District/Area Committee Structures

As a way of addressing a commitment in the Programme For Government, in 2021 Minister Peter Burke undertook a review of Putting People First - Action Programme for Effective Local Government (2012) which includes considering the provision of best practice recommendations on the operation of Municipal Districts and Area Committees.

In May & June 2021 Minister Burke issued a survey to all elected members to gauge their opinion on the current operation of municipal districts and area committees. The survey results were published in December 2021 and this was followed up with a workshop with Elected Members on 26th January 2022. The Association also held a roundtable workshop session in January with 70+ of our councillor delegate body on the municipal districts and area committees' structures.

Mandate and Money were identified as two of the biggest issues by elected members in relation to the workings of the Municipal Districts with members citing lack of finance and meaningful budget at MD level as areas which could be improved. Similarly, Area Committees were identified by councillors as a good forum for discussion on local issues but highlighted that they are too large and lack both a budget and a chairperson's allowance. Following the department workshop session on the 26th January last, it was agreed that the Department would continue to engage with elected members through AILG as they continued their review of the Municipal District & Area Committee structures throughout 2022.

The Association had a follow-up meeting with the DHLGH in April 2022 during which AILG channeled the feedback received from our delegates at the January workshop session.

The AILG prepared a number of papers to submit and engage with the Department as part of the review. The Association highlighted the main themes arising from the consultation with its members including concerns around Town Teams. The AILG voiced the importance of having councillor representation on Town Teams and proposed that all councillors within the Town Area should be on the Town Teams Committee.

## AILG voices Councillor's feedback on PPN Structural Review

In October 2022 an AILG delegation led by President Cllr. Crossan met online with officials from the Department of Rural and Community Development (DRCD) to discuss the Public Participation Network (PPN) structural review.

During the meeting the AILG delegation highlighted key findings from a consultation workshop carried out at the Association's October Plenary meeting. These included the significant lack of awareness of PPN's amongst elected members (in particular newly elected councillors since 2019) in relation to the role, remit and work of their local PPN and the current lack of connection/engagement between elected members and PPN which can lead to conflict between councillors and PPNs.

Other significant issues raised by AILG included the fact that local interaction with PPNs only takes place with elected members sitting on LCDCs or at SPC level and the fact that many councillors were unaware of the Memorandum of Understanding between their local authority and their local PPN.

The Association stressed the need for more engagement between the PPN structures and elected members and the need to foster better relations. The Department thanked AILG and the members for their honesty in relation to the issue and acknowledged the importance of keeping an open line of communication with the association going forward. Following the publication of the report in July, a PPN Implementation Roadmap Working Group was established which the Association will continue to channel the feedback and voice of the elected member through its Working Group nominee, Cllr. Charlie Farrelly.

A successful outcome of the engagement with the Department to date was the agreement to have biannual meetings and the DCRD welcomed the opportunity to partner with AILG to undertake a programme of training and awareness of the PPNs and DRCD community funding streams with elected members in the new year.

### Submission to the Oireachtas Public Accounts Committee on accountability and transparency of Local Authorities

In July 2022 the AILG submitted a paper to the Members of the Oireachtas Public Accounts Committee on Governance, Oversight and Accountability of Local Authorities. The submission dealt with a number of key issues including;

- The significant increase in briefing documentation as a direct result of the increased powers and functions that members now have responsibility for.
- Training and development of elected members around areas such as the local authority budget process
- The volume of technical documents and information that our members must be familiar with on an ongoing basis.

AILG and the Department have identified the potential for further capacity building which needs to be undertaken to build understanding of the critical governance and oversight role of our members, including capacity building around the full suite of reserved powers and statutory functions at the disposal of our elected members. AILG will continue to assist in programmes for further capacity building of elected members in their oversight, governance and compliance role.

### AILG appearance before the Joint Committee on Environment and Climate Action

On 31 May 2022 AILG appeared before the Joint Committee on Environment and Climate Action to contribute to their work and to discuss both the challenges and opportunities for local authorities in climate action. The Association highlighted the challenges local authorities particularly around resources, noting that over the last 10-15 years local authorities have seen a reduction on staff numbers. President at the time, Cllr. Nicholas Crossan noted that if the targets on climate action set by the government are to be delivered at local government level, local authorities would need much needed additional resources.

The Association concluded its contribution by asserting that in order to ensure that the local government sector plays its part in achieving the 51% reduction in gas emissions by 2030 it is essential that we build the capacity of local authorities to lead locally and engage citizens and communities on climate change and biodiversity.

#### **Department Review of Strategic Policy Committees**

The Department of Housing, Local Government and Heritage is currently undertaking a review of Strategic Policy Committees which were introduced as part of local government reform and to broaden involvement in local government through participation by community and sectoral interests.

The aim of the review is to examine how well the SPCs are achieving their stated purpose; to identify facets of their structure, organisation and operation that are impacting on the effectiveness of the SPCs and to make recommendations. As part of the review a stakeholder working group was established in September 2022 and Cllr. Anne

Colgan and Cllr. Nick Killian were appointed as AILG representatives by the Association. The review is in its infancy stage and AILG has already begun consultation work with its members via the vehicle of the Plenary body, carrying out a round table discussion with delegates at its November meeting.

Over the course of 12 months, the AILG Executive and President also worked on other important policy issues including;

- JPC's & Local Policing Forums
- Housing issues Social Housing Provision,
   Tenant Purchase Scheme, Social Housing
   Income Thresholds
- Town Centre First and Town Teams
- Local Government Finance & Resources/LPT/Budgetary Process
- Local Property Tax and incoming changes to Equalisation Fund

## Research and policy: Partnership with Maynooth University

In 2021 the AILG entered a two-year Strategic Partnership with Maynooth University (MU) and its International Centre for Local and Regional Development (ICLRD) as part of our strategic goal to advance AILG's Professional Policy, Research and Advocacy Programme.

An agreed project as part of the strategic partnership was an independent research study on "The 21st Century Councillor in Irish Local Government" which would be undertaken by Maynooth University, with support and collaboration from AILG. A key purpose of the research was to look at the many other facets of the councillor role such as civic leadership, community representational role etc as well as the challenges facing the councillor in an everchanging landscape & the evolution of the role over the past decade.

The rollout of the research had two strands; a national online survey (quantitative) and one-toone in-depth interviews/focus groups (qualitative) with a cross-section of councillors (members who are aged under 30, first-time councillors, women councillors, members from ethnic minority groups etc, ensuring that there was an even geographical spread). Following the launch of the national survey at AILG's Annual Conference in March 2022, the Association engaged in a vigorous promotional campaign with our membership in order to meet our target response rate. With the support of the Executive Committee and Plenary delegates, the Association surpassed the response rate target receiving over 500 responses from councillors across the State.

The Maynooth Research Team also presented to the Regional Assemblies at their member meetings to highlight the research to them and to encourage them to self-nominate for interviews as part of the qualitative research. The qualitative research would include a total of 60 interviews and 3 focus groups of approx. 7-8 people which gave a representative population of about 1/9 of the total membership, providing a rich evidence base to draw from.

A Steering group committee was also formed which included five external nominees to ensure and protect the independence of the research;

- Managerial, Political and Academic Specialists: Séamus Neely (former CEO of Donegal County Council); Noel Dempsey (former TD and Minister for the Environment); Dr Bríd Quinn (formerly UL; currently a member of the Group of Independent Experts of the CLRAE); Dr. Bernie O'Donoghue Hynes (Head of Research, LGMA)

The Maynooth Research Team will present an initial summary of key findings from fieldwork to the Steering group committee in December 2022 with an extensive communications campaign and launch of the findings planned for 2023.

## Engagement with stakeholders in the Local Government context

#### **Engagement with Northern Ireland colleagues**

On 3 March 2022 the Association met with senior committee members from the Northern Ireland Local Government Association (NILGA) in the city of Newy. NILGA made a series of presentations to AILG on current issues in Northern Ireland Local Government and also gave an overview of their "Councils Make it Happen" Campaign which highlighted Council responsibilities and how to use community-based services to support economic growth.

AILG then made a series of presentations to NILGA members detailing the structures and functions of local government in the Republic of Ireland, the Directly Elected Mayor with Executive Functions in Limerick City and County Bill and results of the AILG-CMG survey highlighting the issue of harassment and intimidation faced by elected councillors during the course of their work. Both sides noted that there were a lot of similarities between the two local government systems and shared information on planning, housing, discretionary funding, policy committees, local economic development and councillor supports.

Following informal discussions between President Cllr. Pat Fitzpatrick and NILGA President Cllr. Martin Kearney at the National Association of Councillor's AGM in October 2022, both organisations are currently laying the groundwork to collaborate on further dialogue in 2023.

## AILG President attends Northern Ireland Region of the National Association of Councillor's AGM

AILG President Cllr. Pat Fitzpatrick was among those in attendance at the Northern Ireland Region Annual General Meeting which took place on Friday 21 October 2022 at the Glenavon House Hotel, Cookstown Co. Tyrone.

During his attendance at the conference, the President highlighted the importance of cross border relations and noted it was great to engage and build upon the good working relationship that has been established with our sister association chaired by Cllr. Terry Andrews. Cllr. Fitzpatrick also re-connected with members of the Local Authority Members Association (LAMA) and the Northern Ireland Local Government Association (NILGA) who were also in attendance.

# 2 AILG Policy Programme

## President of AILG co-signs historic Sister City Partnership Agreement with the US

A historic moment took place on Sunday 17 July 2022, at the Partnership Agreement Signing Ceremony during the launch of the Irish Local Authority & US State Legislature Sister City Programme at the Mansion House, Dublin.

President of AILG, Cllr. Nicholas Crossan joined Senator Mark Daly, representatives from the American Irish State Legislators Caucus (AISLC), the National Conference of State Legislatures (NCSLorg) and Local Authority Member's Association (LAMA) in signing the partnership agreement which will encourage more strong links between Irish and American local government. The importance of this new sister partnership between Irish Local Authorities and the US State Legislature has never been more timely, particularly considering the ongoing threat of the Good Friday Agreement due to Brexit. Attendees at the ceremony included a delegation of over 55 politicians from across the United States, including State Senate Presidents and/or majority leaders along with Mayors and Cathaoirligh from across Ireland who pledged their commitment to build upon the deep roots of the Irish American friendship. Ireland will be only the 4th country with whom the National Conference of State Legislators signed an international partnership agreement.

## AILG Engagement with NOAC and Local Government Governance, Efficiency & Reform Working Group

On 12 October 2022 newly elected AILG President Cllr. Pat Fitzpatrick had a meeting with the Local Government Governance, Efficiency & Reform Working Group of the National Oversight and Audit Commission (NOAC). The Association discussed local government issues as well as briefing Chair Brian Cawley and Local Government Governance, Efficiency & Reform NOAC Working Group members on the training & work of AILG.

Following this engagement, AILG President Cllr. Pat Fitzpatrick delivered an opening address at the NOAC Good Practice Seminar on Tuesday 25th October which highlighted exciting innovation happening in local authorities across the State. Contributions during the event included the innovative approach adopted by Dún Laoghaire Rathdown County Council to respond to the Ukraine Humanitarian Crisis (Ballyogan temporary rest centre); a communications app developed by Leitrim County Council which streamlines communications between Leitrim County Council, Emergency Services, An Garda Síochána, and community alert groups, and how Dublin City Council is exploring ways that drone technology can enhance and support operations for local authorities.

Other keynote addresses were delivered on the day by Minister Malcolm Noonan T.D. Minister of State for Heritage, NOAC Chair Michael McCarthy, and CCMA Chair Frank Curran.

## AILG meets Irish Council for Social Housing September 2022

Approved Housing Bodies have become significant providers of housing. Some of the AHBs are well known names such as Clúid, the McVerry Trust, Respond and other large scale operations. Others are guite small specializing in the housing needs of, for example, the elderly or those with special needs in a local community. Housing associations generally work closely with the local authority but such communication may not extend to the local councillors who are the people most aware of the housing needs in a locality. With a view to opening a channel of communications with the housing associations, Cllr Nick Killian (Vice President, 2021/22) proposed that the AILG should initiate a meeting with the representative Association for the AHBs - the Irish Council for Social Housing.

An invitation to the Irish Council for Social Housing was readily accepted and on 22 September 2022, Ms Lyndsey Anderson, Housing Development Specialist, and Ms Ailbhe McLoughlin, Director of Policy met with an AILG delegation headed by Cllr Nicholas Crossan, President (2021/22) and Cllr Killian. The ICSH representatives presented an informative overview of the scale of operation of the AHBS together with examples of where they had worked closely with the local authority. There followed a discussion where councillors reiterated

the need for the elected members to be fully briefed about forthcoming AHB schemes in the counties across the country. The importance of training for elected members was also discussed and it was felt ICSH could contribute to councillor training programmes in the area of housing. The meeting concluded with agreement that both organisations would maintain contact where issues of mutual interest arose.

## AILG Meeting with Department of Transport and Speed Limits Review Group

In early November 2022, an AILG delegation led by President Cllr. Pat Fitzpatrick met with Officials from the Department of Transport and representatives of the Speed Limits Review Group to discuss the work of the group and the state of speeding policy in Ireland. Elected Members have a well-informed knowledge of driving patterns throughout the country with their local knowledge being well

attuned to both public acceptability of, and also, on occasion, public resistance to road safety measures. During the meeting both sides discussed the question of speed limits and current issues. The Association asserted the fact that councillors must retain their reserved function for setting Special Limits with some streamlining of the process. Members of the AILG delegation also provided the councillor's experience of what communities want in regard to speed limits and an agreement was made between both sides to reduce the default limit on local roads to 60km/h.

## Engagement with stakeholders in the Local Government context

## AILG President and Vice President attend National Commemoration of War Event

On the 10th July, AILG President Cllr. Crossan and Vice President Cllr. Nick Killian joined the President of Ireland, the Taoiseach and Cathaoirleach and Mayors across the country in remembering Irishmen and Irishwomen who died in past wars or on service with the United Nations. The event occurs annually on the Sunday nearest 11 July - the anniversary of the date in 1921 when a truce was signed ending the Irish War of Independence.

The President is also an ex officio member of the **Bravery Awards Council** chaired by the Ceann Comhairle. The Council meets bi-annually to decide and award recognition for acts of civilian bravery based on reports verified by An Garda Síochana or the Irish Coast Guard.

## AILG President gives opening address at Climate Action Economic and Opportunities Conference

AILG President Cllr. Crossan addressed attendees at the Climate Action and Economic Opportunities – Local Authorities supporting Enterprise Conference which took place over two days on the 12th and 13th of October 2021. The virtual conference focused on looking at climate change through the lens of opportunity, and outlined the pivotal role that elected members and their local authorities can play in the transition to a climate neutral economy. During his opening address President Cllr. Crossan noted that while the journey of transition for local communities was not going to be easy, it was important for councillors as community champions

to try and focus on the positive and exciting opportunities that will come from addressing climate change which can deliver more sustainable communities, homes, new opportunities for jobs and enhanced skills for the future green economy.

#### **External Committees**

The AILG is represented on a small number of external bodies, principally:

- Congress of Local & Regional Authorities Council of Europe

#### **City and County Management Association**

The AILG meets with the CCMA - the body representing the City and County Chief Executives on an annual basis. In December 2021 the Association met with the then CCMA Chair Mr Brendan McGrath, Galway City CE who was accompanied by Mr Owen Keegan, Dublin City Council CE. Issues discussed included: the new expenses system for councillors and the administrative burden on corporate services staff and getting unity across local authorities; Limerick Directly Elected Mayor; the passing of the Planning and Development Large Scale Residential Bill; the AILG-UCC Climate Learning Program and establishment of the Planning Advisory Forum.

A discussion also took place in relation to the return to online and hybrid meetings, with the CCMA highlighting large costs for local authorities in relation to equipment.

## AILG Launches Climate Learning Program in partnership with UCC

In December 2021 President Cllr. Crossan launched the QQI Level 7 Certificate in Continuing Professional Development in Climate Crisis and Local Government in partnership with the University College Cork (UCC). The partnership marked another exciting new chapter for the Association which saw AILG achieve our goal of delivering a bespoke externally accredited training programme and brought us closer to developing our AILG Continuous Professional Development (CPD) Education and Training Programme.

A total of 24 elected members undertook and successfully completed the course which aimed to inform, challenge and empower councillors to confidently navigate their increasingly important role in addressing climate change at a local level.

The Association acknowledged the achievements of the students at its Autumn Seminar in October 2022 whereby Minister Peter Burke, Minister of State at the Department of Housing, Local Government and Heritage made a presentation to the 24 elected councillors from across the country who had completed the course.

On 30 November 2022, the University College Cork also marked the historic occasion by hosting a formal ceremony of completion on their campus . A number of distinguished guests including the Vice President of UCC, Professor Pat McSweeney joined the successful graduates and their families in receiving their certificates. As a representative body, the Association is proud to have cosponsored the programme and AILG are again delighted to announce that we intend to continue our partnership with UCC in offering this bespoke Level 7 Certificate in Climate Crisis and Local Government to our local authority elected members again in 2023.

# 3 AILG Training and Education

#### **AILG hosts successful Annual Training Conference**

More than two years after Covid prompted a shift to remote work and virtual gatherings, the Association was delighted to host its 2022 annual conference in Buncrana, Co. Donegal on the 23 and 24 March earlier this year.

Opened by guest speaker Peter Burke TD, Minister for Local Government, the two-day conference brought together leading local and national experts from the local government sector to discuss various themes which included "Town Centre First – Local Authorities Championing the Local Economic Recovery Post Covid-19".

The event attracted more than 300 delegates from across the country who greatly benefitted from the insights and contributions of presenters and speakers including Kevin Comiskey from the Irish Farmers Association (IFA), Head of Economic Development Ann Marie Conlon and Senior Planner Eunan Quinn from Donegal County Council. The Association also officially launched its national survey on "The 21st Century Councillor in Local Government" and lead researcher for the project, Geographer, Analyst and Social Researcher Brendan O' Keefe led an engaging panel discussion on the joint Research Project between AILG and Maynooth University.

## Council of Europe in focus at AILG Autumn Seminar

As part of Ireland's Presidency of the Council of Europe, the AILG devoted its Autumn Training Seminar to reflecting on the 3 main themes of the Irish Presidency: support for democracy and human rights, youth democratic participation, and equality and inclusion. Almost 300 elected representatives and delegates from across the

country came together in Trim, Co. Meath for a packed programme of discussion. The event was officially opened by Minister Peter Burke, Minister of State at the Department of Housing, Local Government and Heritage who made a presentation to 24 elected councillors from across the country who had recently completed a newly developed UCC accredited course in Climate Action.

Distinguished guest speakers for the first session of the day included Bernd Vohringer, President of the Chamber of Local Authorities of the Congress in the Council of Europe and Larisa Miculet, Moldovan Ambassador to Ireland who discussed the resilience of local government in responding to geopolitical tensions in Europe. A sobering remote address was also delivered by the Deputy Mayor of Bucha in Ukraine, a town which bore the brunt of the assault in March when Russians attempted to take the capital Kyiv.

Minister Thomas Byrne, Minster for European Affairs, was on hand to close the successful two-day event where he spoke about how local politics and democracy are at the core of the Council of Europe. The Seminar was concluded with a special long service councillor awards presentation during which a number of councillors were recognised for serving their local communities for almost 50 years as public representatives. Those honoured on the night included Cllr. Frank McDermott (Westmeath County Council), Cllr. Mary Hilda Kavanagh (Kilkenny County Council), and Cllr. PJ Kelly from Laois County Council.

### **Communications - Email Marketing Campaigns**




Benchmarking our email marketing engagement from 2022 against last year, the Association has seen a **14%** increase in email engagement from our elected members which is a fantastic achievement.


## AILG-Zoom Survey "The Role of Video Conferencing in Local Government" Launch

In November AILG launched a new report 'The Role of Video Conferencing in Supporting Local Government' in collaboration with Zoom.

Informed by a survey of Ireland's 949 elected members, the report outlined how video conferencing supported the continuation of council work throughout the Covid-19 pandemic, the challenges faced in adapting to an online model and the desire to retain a future hybrid model. A total of 139 complete responses were returned by the closing date representing a 15% response rate. Key findings from the report included;

## **AILG-Zoom Survey "The Role of Video Conferencing** in Local Government" Launch

- 77% of respondents believed future statutory council meetings & council related meetings should be conducted as physical meetings with the option to access by video conferencing
- 81% of respondents believe a hybrid environment facilitates better family, personal, work or study balance within their role as an elected representative.
- 51% believe that a hybrid environment will encourage more participation in Local Government from underrepresented groups including women, under 35's, self-employed, full-time carers, and people with a disability.

The survey was well received and AILG received a large volume of media coverage in relation to the survey launch.

# AILG Congress of Local & Regional Authorities in Europe (C.L.R.A.E)

"The AILG has a small but valued involvement through its role as parent body for the Irish delegation of councillors to the Council of Europe's local government forum – the Congress of Local and Regional Authorities (CLRAE)."

The Congress is the forum of the Council of Europe which brings together elected members from 47 European countries to discuss issues of concern in the local government sector throughout the continent. There is an emphasis on issues to do with the participation of minority groups including migrants in all facets of local democracy and the Irish delegates also take part in meetings of the three major committees of the Congress:

Monitoring, Governance and Current Affairs.

## AILG contribution to Irish Presidency of the Council of Europe

The 20th of May 2022 marked the beginning of the Irish Presidency of the Council of Europe (COE), its first time to hold such a prestigious mandate in over twenty years. This milestone provided an opportunity for the Irish Delegation of councillors, supported by AILG, to consider ways in which Irish local government could deepen its engagement with the Council of Europe within the framework of existing meetings and activities.

As well as devoting its Autumn Training Seminar to the Council of Europe, the Association carried out a number of activities to mark Ireland's six-month Presidency of the Council of Europe.

# **AILG Congress of Local & Regional Authorities in Europe (C.L.R.A.E)**

## AILG Host Bureau of Congress Meeting in Partnership with Kerry County Council

To mark the Irish Presidency of the Council of Europe, the Bureau of Congress met in early June in Tralee, County Kerry to discuss a variety of topics and hear from a range of speakers which included Kerry Mayor and Head of the Irish Delegation to Congress Cllr. Jimmy Moloney, AILG President Cllr. Nicholas Crossan and President of the Congress Leen Verbeek.

The Bureau of Congress, also known as the Executive Committee of the Congress of Local & Regional Authorities in Europe is the local



government assembly of the overall Council of Europe. Over 27 Local government elected members from Sweden, Germany, Belgium, NL, France, Austria, Georgia, Serbia, Armenia, the UK and, notably, Ukraine, were present at the meeting where Russia's invasion of Ukraine was one of the top issues discussed.

An emotional Ukrainian reunion took place at the beginning of the meeting as Ukrainian families housed by Kerry County Council had the opportunity to speak with congress members and meet with Ukrainian elected member Svitlana Bohatyrchuk Kryvko who delivered a powerful speech to the Congress. During his welcome address to the Congress, Cllr. Crossan offered his full support and solidarity with Ukraine and thanked the Ukrainian families present for sharing their experience. In his concluding remarks, Cllr. Crossan warned that "Putin's Ukraine invasion has been a wake-up call for a world taking democracy for granted."

# AILG Executive Committee Study Visit to the Council of Europe

In light of the Irish Presidency of the Council of Europe, the AILG National Executive Committee travelled to the Council of Europe in Strasbourg at the end of June 2022. The purpose of the study trip was to engage with the European organisation, which was founded in the wake of World War II to uphold human rights, democracy and the rule of law in Europe.

Over the course of two days, the AILG delegation had a busy schedule of engagements with a number of key personnel including Minister Thomas Byrne, TD, Minister of State at the Department of Foreign Affairs, Judge Siofra O'Leary, President of the European Court of Human Rights

and Mr Breffni O'Reilly, Irish Ambassador to the Council of Europe.

AILG Executive Committee members Cllr. Joe Leddin and Cllr. Gráinne Maguire also met and spoke with youth groups at the Palais de l'Europe as part of a Council of Europe campaign to increase young people's role in the process of revitalising participatory democracy in the Council of Europe. Across its six-month Presidency term, Ireland pursued three clear and complementary priorities, with the overarching aim of renewing "the conscience of Europe" in the wake of war on our continent. At a time of turmoil, Ireland reaffirmed 'Our Founding Freedoms', by refocusing on human rights protection for civilians across Europe, above all through the vital work of the European Court of Human Rights (ECHR).
